It is very important to get this station back into service before our big demand hits. We can fill the elevated tanks quite full, so it is not affecting us much at this time with lower usage in the system. GM Boniface reviewed the contract, if the project is not complete by the date on the contract, we can move forward with liquidated damages of \$1,200 a day until it is in service, but he is not advocating that we do that at this time. GM Boniface will read through the contract more and get with our engineer to get this project moving quicker.

The elevated storage tank needs to be re-coated because of peeling paint. DB checked and the tank is still under warranty to have this complete.

GM Boniface went over a few new potential improvements in the system, including a subdivision on FM 2409 and a new RV Park on Highway 36.
